

IMPORTANT COMPONENTS OF OUR ENVIRONMENTAL POLICY

- > The reduction of greenhouse gas emissions is constantly monitored by regular external audits.
- > We place great emphasis on improving energy efficiency as part of counter-cyclical renovation work and new construction. All new investments and new processes are assessed in terms of environmental protection and conservation of resources. This includes state-of-the-art technologies to protect water and air quality.
